Discussion regarding ARPA funding IGA process with Douglas County IGA will be forthcoming once provided by the County.

Budget discussion for the period ending December 31, 2023

Sarah Shepherd presented the DRAFT 2023 Budget prepared by Neil Schilling. Discussion followed. The Board agreed with the recommended 5% rate increase for most water and sewer fees, except for water usage rates for usages in excess of 20,000 gallons, and construction/bulk water, which have been budgeted with a 10% increase.

Operations: Operators Report

Will Parker gave the Board an update on irrigation repairs, which are about 4 weeks out. A couple of meters also need to be replaced.

Water and Wastewater Organization Membership Discussion

Sarah Shepherd and Matt Collitt gave the Board an update on this membership option to the Colorado Water Congress Membership. It may be a good option for education, representation at the State level, networking, workshops, and information regarding available Grants. Discussion followed.
